(Revenue \$) THE ROOTS YOUNG ADULT SHELTER OPENED IN 1999 BECAUSE THERE WAS AN UNMET NEED FOR SHELTER SPECIFICALLY FOR YOUNG PEOPLE BETWEEN 18 AND 25, AS THIS POPULATION IS TOO OLD FOR YOUTH SHELTERS BUT IS UNCOMFORTABLE IN PROGRAMS THAT SERVE OLDER ADULTS. THIS 45-BED SHELTER PROVIDES A SAFE, DRY PLACE TO SLEEP, HOT MEALS, HYGIENE FACILITIES, AND ACCESS TO CASE MANAGEMENT SERVICES FOR OUR GUESTS 7 NIGHTS A WEEK. ROOTS PROVIDED 12,935 BED NIGHTS TO 469 UNDUPLICATED GUESTS IN 2023 AND SERVED APPROXIMATELY 29,673 MEALS DURING THAT PERIOD. VOLUNTEERS DONATED APPROXIMATELY 12,920 HOURS OF THEIR TIME TO HELP PROVIDE THESE SERVICES.
